Lamp Post Rules: The Lake Pointe Restrictions and Covenants require that your exterior lamp post must be lighted at night for neighborhood safety. A common cause for lamp posts not working is the failure of the transformer inside the fixture. HOA member Don Dorsan can rebuild your fixture to accept the more efficient LED light and restore it to working order. HOA BOARD UPDATES

Community Education and Recreation Center (CERC) addition and new soccer fields: Construction is underway west of the existing center on Forest Hill Ave. Lake Pointe Estates (LPE) board members attended project presentation meetings that raised our concerns about potential fertilizer and weed treatment run-off problems from the new soccer fields into the LPE pond. Subsequent letters were sent and meetings initiated by the Board with The School District, City engineers, consultants, Mayor Nelson and Alder Michelle Eichman, where we voiced our opinion that the run-off mitigation system, as currently designed, is an inadequate solution to potential problems, which could raise our pond treatment costs and subsequently our HOA dues. At the most recent meeting, the School District agreed to get estimates on a potential compromise and follow up with us. Ongoing developments will be posted on the LPE website. QUESTIONS FROM THE NEIGHBORHOOD

Why are the neighborhood street lights different colors and brightness? Is the City retro-fitting the lights? The City of Franklin contracts street lighting installation, repair and replacement from WE energies, making WE energies the responsible party for the street lights. As far as Franklin Public Work's is aware there is no overall neighborhood upgrade/retrofit program in either Franklin or WE energies plans at this point. WE energies will replace non-functioning lights with LED units as needed. Go to:

What can I do about unleashed dogs in the neighborhood? In Franklin, Wisconsin, dogs must be on a leash when off their owner's property and the leash must be no longer than 12 feet. The dog must also be under the control of a person competent to control it. The City has an online form to file an Ordinance Violation.
